

# TRANSFER CONDITIONS MAREEBA DIMBULAH WATER SUPPLY SCHEME

These local transfer conditions are to be read in conjunction with the conditions as set out on the Temporary Transfer Application Form.

# Loss Adjustments

Under normal conditions there are no loss adjustments for the scheme. SunWater will advise applicants if a loss adjustment will be required.

## **Trading Caps**

Maximum Allowable Volume and Conditions for temporary transfer

A temporary transfer of a volume of water may be approved provided that the total water use in a water year for each zone does not exceed the maximum water use volume in the table below for each zone.

| Resource Operations Plan zone | Zone A    | Zone B    | Zone C    | Zone D   | Zone E    |
|-------------------------------|-----------|-----------|-----------|----------|-----------|
| Maximum water use             | 15,000 ML | 13,500 ML | 20,000 ML | No limit | 29,500 ML |

# Transfers into East Barron system

Generally NO temporary transfers are allowed into the East Barron system due to capacity restrictions, however:

- Temporary transfers are allowed into East Barron system when the Announced Allocation (AA) is 100% or less and when there is no capacity restriction in place. Capacity in the system would come available when a temporary transfer of water allocation out of the East Barron System has occurred (ie volume of water transferred out in a current water year allows for that volume of water to be transferred back in during the same water year). This transfer will be assessed and approved on a first in first served basis at the time the application is received.
- If AA is less than 100% on 1 April, temporary transfers may be allowed into the East Barron System up to the difference between the current announcement and 100% (Full Capacity) for example: if the AA is 65% then 35% of an individual's total allocation can be transferred into East Barron. A decision to approve temporary transfers of this type will be made on the 1 April each year depending on the AA and operational conditions at that time. This decision will be communicated to all customers in the East Barron system by SMS & Email. Temporary transfers of this type will not be accepted before 1 April each year will only be approved after the decision has been communicated to customers.

## Other

Additional restrictions on temporary transfers may be applied, for example, in extremely dry conditions or when there is a marked transfer of water to high loss areas, at SunWater's discretion

## Transfer Adjustment Fee

A Transfer Adjustment Fee, equal to the value of SunWater's applied irrigation price subsidy, will be payable where water is transferred from a regulated irrigation pricing use to a non-irrigation use. It is the responsibility of the parties to any such transfer to contact SunWater to ascertain this fee in advance of settlement.

A Transfer Adjustment Fee, equal to the value of any other SunWater subsidy or discount to full commercial pricing, will also be payable where water is transferred from any other subsidised use to a non-subsidised use. Again, it is the responsibility of the parties to any such transfer to contact SunWater to ascertain this fee in advance of settlement.
