Announced Allocation

Under the rules of the Interim Program (approved June 2017) the current announcement for Medium Priority is 10% with no guarantee on the delivery.

The Announced Allocation was reviewed effective 01.10.2017. The outcome of this review resulted in no change to the current announcement.

Water Deliveries commenced on 09.09.2017 to supply water ordered under the 10% interim program. 2239Ml was released to deliver 800ML. Losses were greater than expected.


