4. General Business

Flood Events

Nev discussed the approach SunWater has to flood events in particular the communication strategy with Stakeholders further information will be forwarded to the IAC and the Banana Shire council. Cr David Snell will advise SunWater when the next counter disaster meeting is to be held.

Water Pricing

Following up on a query from Mark Gooding on water pricing Nev Wogandt provided update with process involving QCA, and the access to the QCA web site for further updates.

Water Boards

Cr David Snell advised that Councils were no longer going to be handed responsibility for Rural Water Boards

Recycled Water

Cr David Snell advised that Banana Shire Council had found good uptake of recycled water in Biloela however was still looking for more use in Moura.

Kroombit Storage

Kroombit currently storing 8900 ML, release is approx 40 – 50 ML /day.

Potential for Increasing Allocation

Trevor Goos suggested that there was evidence to support increasing section 8A, particularly given that it is a small area with limited no. of irrigators. Bore levels approaching 2006 levels.
