As at the 20.11.2017 the High B & Medium Priority release (cut-off) level has been reached. Releases for Medium Priority allocation cannot be made now until inflows are received and the storage level rises above 460.35mAHD (15,005ML).

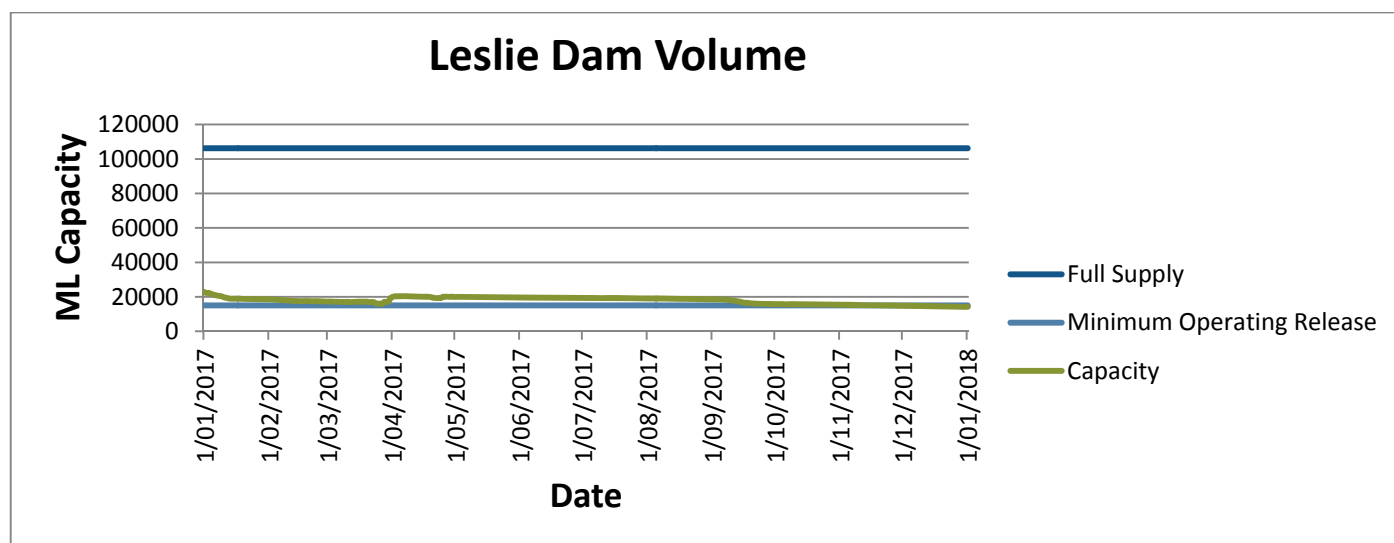
