Introduction

The Commonwealth Water Charge (Infrastructure) Rules, which apply within the Murray Darling Basin and are administered by the ACCC, require SunWater to provide an information statement with the pricing schedule. The following information is provided as required by the Rules.

Adjustments to regulated charges from the network service plans estimates

Updated NSP's were issued to each customer in June 2012 and referenced the QCA final reports and recommended charges. The charges subject to the Rural Irrigation Water Pricing Direction listed above are based on the June 2012 NSPs and the QCA final reports. The Queensland Government used this information to determine the price path which has been extended to 30 June 2019.

Explanation for different regulated charges for the same class of infrastructure service

In addition to charges subject to the Rural Irrigation Water Pricing Direction SunWater sets commercial charges applicable to non-irrigation water users. These charges include a greater contribution towards a return on the capital invested in the Water Supply Scheme in line with Queensland Government policy. The fees and charges, other than those subject to the Rural Irrigation Water Pricing Direction, have been maintained in real terms by escalation from the previous year at the Brisbane All Groups CPI for March 2012, except where individual supply contract terms indicate otherwise.
