Addendum 1 to Appendix H of the *Rookwood Weir Water Allocation Sales Information Memorandum May 2020* (Information Memorandum) provides the following updates and additional information:

1. The Lot on plan areas (Table H.1) have been corrected.
2. The area of analysis (as noted on page 131) is only for five kilometres either side of the Lower Fitzroy River within the Rookwood Weir impoundment area (i.e. upstream of the proposed Rookwood Weir site).
3. The source of the information for Agricultural Land Classes is the Queensland Agricultural Land Audit is the Department of Agriculture, Fisheries and Forestry (2013) (now known as the Department of Agriculture and Fisheries) (not Pricerfinder). The first line of Section 5.3 on page 56 should read “A landholdings analysis, included in Appendix H, outlines the size of land parcels within the Rookwood Weir impoundment area.”

Although the Lot on Plan analysis provides a guide to a particular land parcel, in reality, farms and landholdings are often made up of a number of Lot on Plans. Addendum 1 to Appendix H includes additional spatial analysis to provide more information on Agricultural Land Classes at a farm scale.

The analysis used the Rural Properties – Queensland dataset (DNRME 2020), which contains named rural properties (horticultural or agricultural properties). The analysis provided determines the amount of Class A (crop land) and B (limited crop land) on named properties larger than 200 hectares within the Rookwood Weir Assessment Area (as defined in Section 6: Glossary of the Information Memorandum).


The analysis outlined in Table H.2 shows 75 properties with a total of 134,391ha of Class A and B land and lists. These properties are listed in order of size - from the largest to the smallest.

A landholdings analysis, included in Appendix H, outlines the size of land parcels within the Rookwood Weir impoundment area. This land analysis also sets out the amount of agricultural land classes for each land parcel, categorised as follows:

- A1 – Suitable for a wide range of current and potential broadacre and horticultural crops
- A2 – Suitable for a wide range of current and horticultural crops only
- B – Suitable for a narrow range of crops. The land is suitable for down pastures and may be suitable for a wider range of crops with changes to knowledge, economies or technology
- C1 – Suitable for grazing sown pastures requiring ground disturbance for establishment or native pastures on higher fertility soils
- C2 – Suitable for grazing native pastures, with or without the introduction of pasture, and with lower fertility soils than C1
- C3 – Suitable for light grazing of native pastures in accessible areas and includes steep land more suited to forestry or catchment protection.
