### Lower Mary River Water Supply Scheme

June 2020

#### Scheme overview for 2019-2020

Due to ongoing drought conditions and lack of inflows, triggers for medium priority cut-off were met on 4 January 2020 when the level of Mary Barrage reached EL 1.0m AHD. After some welcome rainfall in the region, medium priority allocation holders could take water again on 24 January 2020 when the level went above EL 1.2m AHD.

The table below shows scheme usage and remaining balances as at 31 March 2020.

#### Important message regarding water availability

Water supplied from Mary Barrage to medium priority water allocations for irrigation use must cease when the barrage's water level is equal to or less than EL 1.0m AHD.

The cessation continues until the water level is equal to or greater than EL 1.2m AHD.

#### Water pricing

The Queensland Competition Authority (QCA) has completed its investigation into water prices for Sunwater's irrigation customers from 1 July 2020 to 30 June 2024. The irrigation price review allowed for a thorough examination of our costs and provided an opportunity for stakeholders to present their views on issues affecting them before the QCA recommended future irrigation water prices to the Queensland Government. For 2020/21, the Queensland Government has announced that prices will be the lower of:

- the existing 2019/20 price
- the 2020/21 price recommended by the QCA.

Sunwater will notify irrigation customers of the actual prices to apply in 2020/21 once we receive the Rural Water Pricing Direction Notice from the Queensland Government.

At this stage, the Queensland Government has not announced the irrigation prices that will apply for the remainder of the price path period (2021/22 to 2023/24). The Queensland Government has however, confirmed that it will continue to subsidise the irrigation customer's share of Sunwater's Dam Improvement Program costs.

### Would you like to receive your invoice via email?

Over the 2018/19 year, a total of 19,074 invoices were generated. The vast majority of these (87 per cent) were posted, with a small portion being emailed (13 per cent).
